## AFFIDAVIT OF BOUNDARY DESCRIPTION OF AMENDED WATER SERVICE AREA FOR THE CITY OF NEW BOSTON AND CENTRAL BOWIE WATER SUPPLY CORPORATION PUC DOCKET NO. 52646

"By our signatures below, **Mr. Ronald Humphrey**, as the Mayor of the City of New Boston, Texas, ("New Boston") and **Mr. Hal Harris**, as General Manager of Central Bowie Water Supply Corporation, (Central Bowie WSC) being duly sworn, file this joint affidavit; that in such capacity, are qualified and authorized to file and verify such form, and that all the statements made and matters set forth therein are true and correct.

We are personally familiar with the boundary description of the service areas set out in the approved Certificates of Convenience and Necessity ("CCN") and map for water service which has been amended as follows:

- Approximately 2,288 acres from Central Bowie County WSC's certificated service area under CCN number 10525 was transferred to New Boston's certificated service area under CCN number 13164;
- Six (6) acres from Central Bowie County WSC's certificated service area under CCN number 10525 was transferred to the applicants' dually certificated service area under CCN numbers 13164 and 10525;
- 56 acres from New Boston's certificated service area under CCN number 13164 was transferred to Central Bowie County WSC's certificated service under CCN 10525;
- 713 acres from New Boston's certificate service area under CCN number 13164 was transferred to the applicants' dually certificated service area under CCN numbers 13164 and 10525.

The service areas described above are set out in the certified copy of the PUC Notice of Approval and approved CCN map attached to this affidavit as <u>Exhibit A</u>.




