PETITION OF THE CITY OF NEW BOSTON AND CENTRAL BOWIE COUNTY WATER SUPPLY CORPORATION FOR APPROVAL OF SERVICE AREA CONTRACT UNDER TEXAS WATER CODE § 13.248 AND TO AMEND CERTIFICATE OF CONVENIENCE AND NECESSITY IN BOWIE COUNTY

BEFORE THE PUBLIC UTILITY COMMISSION OF TEXAS

FIRST AMENDED PETITION FOR APPROVAL OF SERVICE AREA CONTRACT UNDER TEXAS WATER CODE § 13.248 AND TO AMEND WATER CERTIFICATES OF CONVENIENCE AND NECESSITY IN BOWIE COUNTY, TEXAS

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COME NOW, the City of New Boston, Texas ("*City*"), a Type A general law municipality and retail public utility, and Central Bowie County Water Supply Corporation ("*Central Bowie County WSC*"), a non-profit water supply corporation and retail public utility (collectively, "*Petitioners*") and file this First Amended Petition for Approval of Service Area Contract under Texas Water Code ("*TWC*") § 13.248 and to Amend Water Certificates of Convenience and Necessity in Bowie County ("*Amended <u>Petition</u>*").

This Amended Petition is filed in response to Order No. 2, in which the administrative law judge determined that the Petition was deficient for the reasons described in Commission Staff's Comments Regarding Administrative Completeness and Notice and the November 3, 2021 memorandum of Jolie Mathis attached to Staff's Comments (the "Staff Memorandum"). Order No. 2 set a deadline of December 3, 2021 for Petitioners to supplement the Petition to cure the deficiencies described in the Staff Memorandum.

The Staff Memorandum describes mapping deficiencies and requests clarification regarding Petitioners' filing the Petition under both TWC § 13.248 and §13.255. Specifically the Staff Memorandum requests clarification about the intent of filing the petition under both TWC § 13.248 and § 13.255. Central Bowie County WSC and the City executed the "Agreement Regarding Water Utility Service to Designated Areas" (the "Contract"), which is the underlying Contract to this Amended Petition, as a settlement to a separate proceeding before the Commission.¹ There, pursuant to TWC § 13.255 (a) and (b), the City issued notice to Central Bowie County WSC of its intent to provide service to four parcels that it had annexed.² In response, Central Bowie Count WSC petitioned for a cease and desist order.³ The Petitioners ultimately settled by executing the Contract pursuant to TWC § 13.255(a) and TWC § 13.248, both of which allow retail public utilities under certain circumstances to amend their respective certificates of convenience and necessity ("CCNs") by agreement, upon Commission approval. That Contract is the basis for this Amended Petition. Given the complexities of the mapping implicated by filing under both TWC §§ 13.248 and 13.255, Petitioners now seek Commission approval of the Contract pursuant only to TWC § 13.248.

This Amended Petition is timely filed and Petitioners suggest that the style of the case be modified as shown above to reflect that the matter is brought under TWC § 13.248 alone.

I. **PETITION**

 Pursuant to TWC § 13.248 and 16 Texas Administrative Code ("<u>TAC</u>") 24.253, contracts between retail public utilities designating areas and customers to be served ("<u>Service Area</u>")

<u>*Contracts*</u>") are valid and enforceable and are incorporated into the CCN of the retail public utilities if approved by the Commission after notice and hearing.

- 2. The City is a "municipality" as defined by TWC § 13.00(12) 16 TWC § 24.3(21) and a "retail public utility" as defined by TWC § 13.002(19) and 16 TAC § 24.3(31), and holds water CCN No. 13164, the boundaries of which are within Bowie County, Texas (the "<u>City</u> <u>CCN</u>").
- 3. Central Bowie County WSC is a "water supply corporation" as defined by TWC § 13.002(24) and 16 TAC 24.3(40), and a "retail public utility" as defined by TWC § 13.002(19) and 16 TAC § 24.3(31), and holds CCN No. 10525, the boundaries of which are within Bowie County, Texas (the "*Central Bowie County WSC CCN*"), and which abut the western boundaries of the City CCN.
- 4. As provided by TWC § 13.248 and 16 TAC 24.253, Central Bowie County WSC, a nonprofit water supply corporation serving retail public water service within its CCN area boundaries, may enter a Service Area Contract with New Boston, a municipality and retail public utility, designating the areas to be served by each.
- 5. Central Bowie County WSC and the City have entered into the Contract designating water service areas and customers to be served. A copy of the Contract is attached hereto as

Exhibit "A".

- 6. The Contract:
 - transfers portions of the City CCN to the Central Bowie County WSC CCN (the "<u>Requested Areas to Transfer from the City CCN to the Central Bowie</u> <u>County WSC CCN</u>");

- ii. transfers portions of the Central Bowie County WSC CCN to the City CCN (the "<u>Requested Areas to Transfer from the Central Bowie County WSC</u> <u>CCN to the City CCN</u>"); and
- iii. establishes certain dual certification areas (the "<u>Requested Areas to Dual</u> <u>Certify with the City CCN and Central Bowie County WSC CCN</u>").
- No existing customers or facilities of either the City or the Central Bowie County WSC will be transferred under the Contract or pursuant to this Amended Petition.
- 8. Under 16 TAC § 24.253(b), retail public utilities may request approval of a Service Area Contract by filing a written petition with the Commission that includes the following:
 - i. Maps of the requested area in accordance with 16 TAC § 24.257(a);
 - ii. A copy of the executed Service Area Contract;
 - iii. The number of customers to be transferred, if any;
 - iv. Notice information in accordance with 16 TAC § 24.253(c);
 - v. Any other information required by the Commission.
- 9. The Contract was discussed and authorized by the Board of Directors of the Central Bowie County WSC at its regular meeting held on December 1, 2020. Copies of the meeting notice, agenda, and minutes for the meeting during which the Contract was discussed by the Board, and an affidavit from Hal Harris, General Manager of Central Bowie County WSC, attesting to the date that notice was provided, are attached hereto as Exhibit "B."
- 10. The Contract was discussed by the Governing Body of the City at its regular meetings held on March 16, 2021. Copies of the meeting agenda and minutes for the meeting during which the Contract was discussed by the Board are attached hereto as **Exhibit "C."**

- 11. Attached as <u>Exhibit "D"</u> is an affidavit from Ronald Humphrey, Mayor of the City attesting to the date that notice was provided, and which includes a copy of the meeting notices that were issued (the "<u>City Affidavit</u>").
- 12. Attached as **Exhibit "E"** is the following mapping information:
 - a large-scale general location map identifying the transfer areas in reference to the nearest county boundary, city or town (Exhibit "E-1");
 - ii. five maps identifying the Contract Areas in reference to verifiable manmade and natural landmarks (Exhibit "E-2"); and
 - iii. digital mapping data.
- 13. The mapping at <u>Exhibits "E-1" and "E-2"</u> provides the CCN boundaries agreed upon by the Petitioners as follows:
 - The Requested Areas to Transfer from the City CCN to the Central Bowie
 County WSC CCN are outlined in red;
 - ii. The Requested Areas to Transfer from the Central Bowie County WSCCCN to the City CCN are depicted with blue hatching; and
 - iii. The Requested Areas to Dual Certify with the City CCN and Central BowieCounty WSC CCN are shaded in green.
- 14. The properties addressed in Paragraph 1 of the Contract and described in Paragraph 1 and Exhibit A to the Contract as Tract One (Lynch), Tract Two (BCDC Properties), and Tract Three (Scott) will *not* be transferred under the Contract but will remain within the Central Bowie County WSC CCN. The Petitioners recognize that if they seek to transfer any of those properties to the City CCN upon the occurrence of the contingencies provided for in

the Contract as it exists now or as it may be amended in the future, a separate filing with the Commission would be necessary.

II. CONCLUSION AND PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioners respectfully request that: (i) this Amended Petition be deemed properly filed with the Commission; (ii) the Commission approve the Contract as provided under TWC § 13.248 and 16 TAC § 24.253; (iii) the Commission enter an order transferring the Area to be Transferred to the City CCN and the Area to be Transferred to the Central Bowie County WSC CCN as requested herein; (iv) the Commission enter an order designating the Dual Certification Areas as requested herein; and (v) all other orders, acts, procedures and relief be granted as necessary to enforce the Contract.

Exhibit "A" (Service Area Contract)

AGREEMENT REGARDING WATER UTILITY SERVICE TO DESIGNATED AREAS

This Agreement is entered into by and between Central Bowie County Water Supply Corporation and the City of New Boston, Texas (cumulatively, the "Parties," and individually, "Party," depending upon the context), and is effective upon execution by the second Party to sign the same.

RECITALS

WHEREAS, Central Bowie County Water Supply Corporation is a non-profit water supply corporation and retail public utility and the current holder of the Certificate of Convenience and Necessity ("CCN") No. 10525 authorized to provide retail public water utility service to specific areas within Bowie County, Texas; and

WHEREAS, the City of New Boston, Texas, is a Type A general law municipality and retail public utility and the holder of CCN No. 13164 authorized to provide retail public water utility service within the City of New Boston, Texas and some adjacent areas; and

WHEREAS, the City of New Boston, Texas, has annexed into the City of New Boston, Texas, or provided water service to the land areas described in Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, areas described in Exhibit "A", together with other areas the Parties desire to realign to facilitate efficiencies of both Parties are described upon the Maps/Plats attached to this Agreement as Exhibit "B"; and

WHEREAS, on August 12, 2020, pursuant to Texas Water Code § 13.252, Central Bowie County Water Supply Corporation filed a cease-and-desist petition with the Public Utility Commission of Texas ("PUC") complaining that City of New Boston was encroaching into its service area defined by CCN No. 10525; and

WHEREAS, on September 29, 2020, pursuant to Texas Water Code § 13.255, the City of New Boston sent notice of intent to provide retail water service to four parcels of land located within recently annexed city limits but located within Central Bowie County Water Supply Corporations' CCN No. 10525; and

WHEREAS, Central Bowie County Water Supply Corporation holds outstanding debt issued by the United States Department of Agriculture-Rural Development's Rural Utilities Service and claims protection of its water utility infrastructure and service area pursuant to 7 U.S.C. § 1926(b); and

WHEREAS, Central Bowie County Water Supply Corporation and the City of New Boston, Texas, desire to provide for the orderly development and expansion of their service areas by memorializing their agreement to cooperate regarding the areas described in Exhibit "A" and

other areas described in Exhibit "B", and enter this agreement in accordance with Texas Water Code § 13.255(a).

NOW, THEREFORE, it is agreed by and between Central Bowie County Water Supply Corporation and the City of New Boston, Texas, as follows:

- 1. Central Bowie County Water Supply Corporation shall provide water service to the properties described as Tract One (Lynch), Tract Two (BCDC Properties), and Tract Three (Scott) and said areas shall remain in the single Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation; provided, however, if the Central Bowie County Water Supply Corporation lines servicing Tract One and Tract Two are not sufficient to provide a fire hydrant, water pressure and/or water supply in sufficient size and quantities to allow the City of New Boston Fire Department pumper trucks to provide fire protection services to said tracts without damaging or collapsing the Central Bowie County Water Supply Corporation supply lines, then the City of New Boston, Texas, may provide water service to Tracts One and Two. The Parties acknowledge that the current Central Bowie County Water Supply Corporation line to provide a fire hydrant and water service to Tracts One and Two is not capable of supporting the New Boston Fire Department pumper trucks. Central Bowie County Water Supply Corporation shall provide adequate water supply and capacity to meet fire hydrant and firefighting requirements by such date agreed upon by the new owners of said tracts and Central Bowie County Water Supply Corporation. If Central Bowie has not upgraded its lines to provide the quality and quantity necessary to support the City of New Boston Fire Department pumper trucks by said date, the City of New Boston, Texas, may extend its water service line to the property described as Tract One and Tract Two, and provide water service. In such event, the Parties will coordinate to file an agreement with the PUC in accordance with Texas Water Code § 13.255 to amend the Certificates of Convenience and Necessity of each Party to show the property described as Tracts One and Two as dual certification areas. The agreement may, in addition to other terms, include compensation to be paid to Central Bowie County Water Supply Corporation.
- 2. The areas described in Exhibit "A" as Tract Four shall be removed from the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, and added to the Certificate of Convenience and Necessity of the City of New Boston, Texas, as a single service area.
- 3. The areas described as "US 82 West" upon Exhibit "B" lying within the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, which lies North of County Road 4008, West of the existing City Limits of the City of New Boston, Texas, South of Interstate Hwy. 30, and East of the Intersection of Interstate Hwy. 30 and County Road 4008, shall be removed from the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, and added to the Certificate of Convenience and Necessity of the City of New Boston, Texas. The area North of Interstate 30 identified in blue shall be removed from the CCN of City of New Boston and added to the CCN of Central Bowie County Water Supply Corporation.

AGREEMENT REGARDING RETAIL PUBLIC WATER SERVICE TO DESIGNATED CERTIFICATED (CCN) SERVICE AREAS PURSUANT TO TEXAS WATER CODE § 13.255 Page 2 of 13

- 4. The property described as Tract Five (Telford Unit Area upon Exhibit "B") Save and Except the locations highlighted in green, shall be removed from the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, and shall be added to the Certificate of Convenience and Necessity of the City of New Boston, Texas.
- 5. The City owned property adjacent to the Prison (Telford Unit Area upon Exhibit "B") where a wastewater treatment plant is currently under construction and a water tower is located, both outlined in red, shall be removed from the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, and added to the Certificate of Convenience and Necessity of the City of New Boston, Texas.
- 6. The areas described by the Parties as the "Old Boston Proposed Dual Certified CCN Area" described in Exhibit "B" currently served by the City of New Boston, Texas, shall be considered as dual service areas and the Certificates of Convenience and Necessity of the Parties shall be amended accordingly.
- 7. The areas described as the "Daniels Chapel CCN Area Map" upon Exhibit "B" shall be realigned and exchanged between the Parties and reflected as single service areas upon the CCNs of the Parties as indicated.
- 8. The areas described as the "FM 1840 CCN Modifications" upon Exhibit "B" shall be realigned, redesignated and/or removed from the CCN of the City of New Boston, Texas, as indicated upon Exhibit "B".
- 9. Each Party will pay the costs and expenses associated with obtaining Amended Certificates of Convenience and Necessity for that Party respectively.
- 10. The City of New Boston may proceed with the installation and provision of water utilities in the areas authorized by this Agreement at its convenience and at its expense.
- 11. Should one of the Parties to this agreement (First Party) damage a water line or other facility of the other party (Second Party) in the course of constructing or repairing its water system, the First Party shall repair the damaged facilities at First Party's expense within 30 days of receipt of written notice from Second Party of the damaging event; provided, however, if the damage results in loss of pressure or inability of Second Party to supply water to one or more of its customers, the repairs shall be made immediately upon receipt of notice from Second Party.
- 12. In accordance with Texas Water Code § 13.255, a copy of this Agreement shall be filed with the Public Utility Commission of the State of Texas by the City of New Boston, Texas, and incorporated into the terms of the respective certificates of convenience and necessity of Central Bowie County Water Supply Corporation and the City of New Boston, Texas.

- 13. The City of New Boston, Texas, at the request of the property owners has agreed to provide wastewater treatment service to the properties described as Tracts One, Two and Three in Exhibit "A". To the extent that Central Bowie County Water Supply Corporation supplies water service to said Tracts One, Two, and Three, Central Bowie County Water Supply Corporation agrees to provide monthly to the City of New Boston the water usage of the owners of the property in order that the City of New Boston, Texas, can calculate its charges to the property owner for sewer service. The Parties will cooperate to schedule when those reports are due to accommodate the billing departments of both entities.
- 14. The Parties agree to attempt to negotiate the terms of an agreement and implement a plan and procedure to address the provision of water service to future areas annexed into the City of New Boston, Texas, which are within the area of the Certificate of Convenience and Necessity of Central Bowie County Water Supply Corporation, which may include compensation as provided by applicable law.
- 15. Upon execution of this Agreement by both Parties, Central Bowie County Water Supply Corporation shall dismiss its Petition for Cease and Desist Order pending before the Public Utility Commission under Docket No. 51160.

Stewart, Executrix, et al, to James C. Davis and wife, Melba O. Davis by deed dated January 2, 1979, recorded in Volume

644, Pages 619-22, Deed Records, Bowie County, Texas, and more described by as follows:

BEGINNING at an iron stake, this point being the Southwest corner of the Gulf Oil Company 5.774 acres now owned by Arnold B. Barfield;

THENCE: North 2 degrees 09 minutes West, 318.69 feet along a fence to an iron stake and fence corner;

THENCE: North 87 degrees 47 minutes East, 210 feet along a fence to an iron stake and fence corner;

Lynch and wife, Nancy Lynch recorded in Volume 3076, Page 90 of the Real Property Records of Bowie County, Texas;

THENCE: N 01°36'52" W, along an existing fence line, same being the East boundary line of the above described 0.967 acre tract, same being the most Southerly West boundary line of the above described 6.944 acre tract, 313.40 feet to a found 1/2" rebar for corner at an existing fence corner;

THENCE: N 88°24'53" E, along an existing fence line, same being the South boundary line of the above described 5.5 acre tract, same being the most Westerly North boundary line of the above described 6.944 acre tract, 452.16 feet to a set 5/8" rebar for corner at an existing fence corner;

THENCE: N 00°21'01" W, along an existing fence line, same being the East boundary line of the above described 5.5 acre tract, same being the most Northerly West boundary line of the above described 6.944 acre tract, 253.68 feet to a set 5/8" rebar for corner;












