COMMISSION STAFF'S REQUEST FOR EXTENSION

On September 27, 2021, the City of New Boston and Central Bowie County Water Supply Corporation (collectively, Petitioners) filed a petition for approval of a service-area contract under Texas Water Code (TWC) § 13.248 and to amend certificates of convenience and necessity in Travis County. Petitioners filed supplemental information on December 3 and 17, 2021.

On November 4, 2021, the administrative law judge (ALJ) filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the administrative completeness of the petition along with a proposed procedural schedule by January 4, 2022. Therefore, this pleading is timely filed.

I. Request for Extension

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requests that its deadline to file a supplemental recommendation be extended from January 4, 2022 to January 24, 2022. Staff requests this extension in order to consider the supplemental information filed by Petitioners in making its supplemental recommendation. Petitioners do not object to this request.

II. Conclusion

Staff respectfully requests entry of an order consistent with this pleading.
