**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On September 27, 2021, the City of New Boston and Central Bowie County Water Supply Corporation (collectively, Petitioners) filed a petition for approval of a service-area contract under Texas Water Code (TWC) § 13.248 and to amend certificates of convenience and necessity in Travis County. Petitioners filed supplemental information on December 3 and 17, 2021.

On January 7, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of January 24, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the administrative completeness of the petition along with a proposed procedural schedule. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requests that its deadline to file a supplemental recommendation be extended from January 24, 2022 to January 26, 2022. Staff requests this extension in order to address an unexpected scheduling issue.

**II. CONCLUSION**

Staff respectfully requests entry of an order consistent with this pleading.
