## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On September 28, 2021, McCart St, LLC (McCart St) filed a petition for streamlined expedited release from Bolivar Water Supply Corporation's (Bolivar WSC) water certificate of convenience and necessity (CCN) number 11257 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). McCart St asserts that the land to be released is at least 25 contiguous acres, is not receiving water service, and is located in Denton County, which is a qualifying county.<sup>1</sup> According to the 2010 Census,<sup>2</sup> Denton County has a population of 662,614<sup>3</sup> and is adjacent to Dallas County, which has a population of 2,368,139.<sup>4</sup>

On March 1, 2022, the Office of Policy and Docket Management filed a memo establishing a deadline of March 16, 2022, for Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a corrected map. The memo also established a deadline of March 15, 2022, for Staff to file a request for extension if necessary. Therefore, this pleading is timely filed.

#### I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to update and correct the map for this docket. Staff requests that the deadline to file a corrected map for this docked be extended to March 21, 2022.
