COMMISSION STAFF'S MOTION TO DISMISS

On December 11, 2020, the City of Schertz (Schertz) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10645 and to decertify a portion of Green Valley Special Utility District's CCN no. 10646 in Comal County, Texas.

On February 1, 2022, the administrative law judge (ALJ) filed Order No. 5, establishing a deadline of March 2, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the administrative completeness of the application and to propose a procedural schedule. Therefore, this pleading is timely filed.

I. MOTION TO DISMISS

To date, Schertz has not supplemented the application in response to Order Nos. 2, 3, 4, or 5. Staff's attempts to reach out to Schertz have been unsuccessful. Given Schertz's lack of participation in this proceeding, Staff recommends that the application be dismissed without prejudice pursuant to 16 Texas Administrative Code (TAC) § 22.181(d)(6) and (7).

II. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the application be dismissed without prejudice.
