PROGRESS REPORT OF DENTON COUNTY ELECTRIC COOPERATIVE, INC., D/B/A COSERV ELECTRIC

Denton County Electric Cooperative, Inc. d/b/a CoServ Electric files this progress report regarding compliance with Section 6 of House Bill 4150 ("HB 4150"), providing information regarding distribution lines on United States Army Corps of Engineers ("USACE") property that CoServ Electric identified as non-compliant in its report and attestation filed in this docket on January 14, 2022 ("Initial Report"). By letter dated March 4, 2022, the Division of Compliance and Enforcement ("DICE") of the Public Utility Commission of Texas ("Commission") requested a progress report and additional information to be filed on a monthly basis. This is CoServ Electric's progress report for January 2024, which is timely filed.

1. Progress Report

In its last progress report, CoServ Electric identified two distribution line segments located in areas that could be suitable for a sailboat and remained non-compliant with the applicable clearance standards in Rule 232 of NESC Standard ANSI (c)(2) ("NESC Rule 232"). These two line segments remain in progress at Lake Lewisville, as described below.

1. Status of engineering design, permitting, and reconstruction.

The status of the remaining distribution line segments is as follows:

- Lewisville 31A USACE has approved the location of new customer-owned meter
 pedestal and underground facilities to four existing boathouses and one security light.
 The customer is working to obtain easement rights to locate the customer's pedestal
 and associated facilities, which are not owned by CoServ Electric. Once the customer
 obtains easement rights and the pedestal is located, CoServ Electric will begin
 construction of new underground service to the customer and remove all existing
 overhead facilities from USACE property.
- Lewisville 34 Redesign for underground facilities completed and submitted to USACE for permit approval. Waiting on USACE approval to begin construction.


