#### PEDERNALES ELECTRIC COOPERATIVE, INC.'S PROGRESS REPORT

Pedernales Electric Cooperative, Inc. (PEC) hereby files this progress report regarding compliance with House Bill 4150 (Utilities Code §38.004), providing information regarding distribution line adjustments PEC referenced in its Supplemental Report and Attestation Regarding Compliance With House Bill 4150 ("Supplemental Report") filed on July 29, 2022. By informal request on December 21, 2022, the Division of Compliance and Enforcement of the Public Utility Commission of Texas ("Division") requested a progress report and monthly filings with additional information.

#### I. Progress Report

In PEC's Progress Report, filed on January 16, 2024, PEC and PUC Staff agreed to allow PEC to file an update in this Project in May 2024, which would include the status of construction to PEC's final open project, Line BUC-0681. In this Progress Report, PEC provides a final report that reflects a completion status to the initially indicated 37 span locations over lakes, including Line BUC-0681, in the attached <u>Progress Report Table 1</u>. This Progress Report constitutes PEC's final report with respect to these locations subject to House Bill 4150 (Utilities Code §38.004) to the Division.
