TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:

In accordance with the Division of Compliance and Enforcement's memorandum of October 4, 2021, LCRA Transmission Services Corporation (LCRA TSC), respectfully submits the following report and supporting affidavit attesting to compliance with Section 6 of House Bill (HB) 4150, 86th R.S., amending Section 38.004(b) of the Public Utility Regulatory Act (PURA).

I. REPORT

All LCRA TSC-owned transmission facilities that cross a lake listed in PURA § 38.004(b) meet the applicable vertical clearance requirements established in Rule 232 of the National Electrical Safety Code (NESC) Standard ANSI (c)(2). The date on which LCRA TSC verified each line's compliance with the applicable NESC standard is provided in the table below:
