COMES NOW, the Gulf Coast Coalition of Cities (GCCC) and files this Motion to Intervene in the above-styled proceeding. In support thereof, GCCC shows the following:

- 1. On October 8, 2021, AEP Texas, Inc., Centerpoint Energy Houston Electric, LLC and Texas-New Mexico Power Company (collectively, the Joint TDUs) filed an expedited petition for approval of interim load management programs for non-residential customers and for an accounting order.
- 2. GCCC has a justiciable interest in this proceeding, as it is a coalition of municipalities located within the service territory of CenterPoint Energy Houston Electric, LLC and Texas-New Mexico Power Company. A list of GCCC cities is included as Attachment A.
- 3. Additionally, GCCC has standing to participate in this proceeding pursuant to Public Utility Regulatory Act (PURA) § 33.025.¹
