COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND NOTICE

On October 12, 2021, Rosendo L. Garcia, Isabel R. Garcia, and Nicholas R. Garcia (collectively, Garcia) filed a petition for streamlined expedited release from Aqua Water Supply Corporation's (Aqua WSC) certificate of convenience and necessity (CCN) number 20962 under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Garcia asserts that the land to be released is at least 25 contiguous acres, is not receiving sewer service, and is located in Bastrop County, which is a qualifying county.¹

On November 15, 2021, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline of January 13, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the sufficiency of the supplemented petition and propose a procedural schedule. Therefore, this pleading is timely filed.

I. ADMINISTRATIVE COMPLETENESS

To date, Garcia has not responded to insufficiencies noted in Staff's November 12, 2021 filing. Staff recommends Garcia be ordered to cure the deficiencies identified by Staff by February 14, 2022. Staff further recommends that it be given a deadline of March 16, 2022 to file a supplemental recommendation on the administrative completeness of the application. Staff respectfully notes that some of the noted deficiencies are related to mapping information, and therefore Staff's mapping experts may be required to assist the Garcia's regarding the supplemental mapping information needed to cure the mapping deficiencies. Therefore, Staff will require at least thirty days to review the same, resulting in Staff's requested deadline of March 16, 2022.

PROCEDURAL SCHEDULE П.

In accordance with Staff's deficiency recommendation, Staff does not propose a procedural

schedule for further processing of the docket at this time. Staff intends to propose a procedural

schedule alongside a subsequent recommendation that the petition be found administratively

complete.

Ш. **CONCLUSION**

For the reasons detailed above, Staff recommends that the petition be found

administratively incomplete, that Garcia be ordered to file supplemental information to cure the

deficiencies in the petition by February 14, 2022, and that Staff be given a deadline of March 16,

2022 to file a supplemental recommendation on the administrative completeness of the

Application. Staff respectfully requests the entry of an order consistent with these

recommendations.
