- 1. "My name is Ty H. Embrey. I am over the age of eighteen years, of sound mind, and am capable of making this affidavit. The facts stated in the affidavit are within my personal knowledge and are true and correct."
- 2. "I am the General Counsel for Aqua Water Supply Corporation ("Aqua WSC"). The Petitioners in the above-captioned matter, Ben F. Vaughan, III, and Frost Bank, as Co-Trustees of the Genevieve Tarlton Dougherty Trust No. 2, for Ben F. Vaughan, III; James Cullen Vaughan, as Trustee of the James Cullen Vaughan GST Exempt Trust; and Catherine A. Payer, as Trustee of the Rachel Catherine Vaughan GST Exempt Trust, as Trustee of the Daniel Benjamin Vaughan GST Exempt Trust, and as Trustee of the Patrick Michael Vaughan GST Exempt Trust ("Petitioners"), own approximately 611 acres of land located in Bastrop County, of which approximately 192.367 acres are
