NOW COMES, Bolivar Water Supply Corporation ("Bolivar") and files this Request for an Extension of Time. In support thereof, Bolivar would show the following.

On April 1, 2022, Sanger Texas Industrial, LLC ("Sanger") and Webb Industrial LLC ("Webb") filed their First Request for Information to Bolivar. Bolivar's responses are due on April 21, 2022. Therefore, this pleading is timely filed.

Pursuant to 16 Texas Administrative Code § 22.4(b), Bolivar may request that the time allowed to file any documents be extended for good cause. The undersigned failed to calendar the deadline to respond to Sanger and Webb's First Request for Information. The failure to calendar was discovered this afternoon. The undersigned has taken measures that such an error in calendaring does not occur again. Bolivar is requesting an extension to gather the requested documents to May 2, 2022.
