**PROPOSED NOTICE OF
APPROVAL**

This Notice of Approval addresses the Electric Reliability Council of Texas, Inc. (ERCOT) six-month initial interim true-up compliance filing, report of recoveries, and notice of default charge adjustment (Compliance Filing), filed on May 12, 2022, to comply with the Public Utility Commission of Texas (Commission) Debt Obligation Order issued in Docket No. 52321.¹

On May 19, 2022, Commission Staff filed a recommendation in this docket. Commission Staff recommended that ERCOT's Compliance Filing be found sufficient and complete. Additionally, Commission Staff recommended that ERCOT's Compliance Filing and the revised default charges contained therein be found in compliance with PURA and the relevant provisions of the Debt Obligation Order.

Consistent with Staff's recommendation, ERCOT's Compliance Filing is found to be sufficient, complete, and in compliance with PURA and the relevant provisions of the Debt Obligation Order. ERCOT's proposed default charges are approved, as filed, with an effective date of July 1, 2022.
