**ORDER NO. 17**  
**APPROVING QUARTERLY TRUE-UP COMPLIANCE FILING AND UPLIFT**  
**CHARGE ADJUSTMENT**

This Order addresses the quarterly true-up compliance filing, report of recoveries, and notice of uplift charge adjustment (compliance filing) filed by the Electric Reliability Council of Texas, Inc. (ERCOT) on September 13, 2024, to comply with the Commission's Debt Obligation Order issued in Docket No. 52322.<sup>1</sup>

On September 19, 2024, Commission Staff recommended that ERCOT's compliance filing be found sufficient and complete. Additionally, Commission Staff recommended that ERCOT's compliance filing be found in compliance with PURA and the relevant provisions of the Debt Obligation Order.

There were no objections to ERCOT's filing or Commission Staff's recommendations.

Consistent with Commission Staff's recommendation, ERCOT's compliance filing is found to be sufficient, complete, and in compliance with PURA<sup>2</sup> and the relevant provisions of the Debt Obligation Order. ERCOT's proposed new daily uplift charge is approved, as filed, effective November 1, 2024.

This docket will remain open for future compliance obligations.


