COMMISSION STAFF’S REQUEST FOR EXTENSION

On October 15, 2021, CSWR-Texas Utility Operating Company, LLC (CSWR) filed an application under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for approval of a pass-through rate change for an increase in the fees billed by the City of Rockport (City).

On November 16, 2021, the administrative law judge (ALJ) filed Order No. 2 establishing a deadline of December 13, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the true-up report, pass through rate change, proposed notice, and issues raised by the ALJ. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. In Order No. 2, the ALJ requested clarification regarding the proposed tariff. Staff requests additional time so that it may thoroughly respond to the ALJ’s request for clarification. Staff respectfully requests that its deadline to file a supplemental recommendation be extended to January 14, 2021.

II. CONCLUSION

Staff respectfully requests an order extending Staff’s deadline to file a supplemental recommendation to January 14, 2021.
