PETITIONER, TROY BRADSHAW, REQUEST FOR EXTENSION

COMES NOW Troy Bradshaw ("Petitioner") and files this Request for Extension regarding his Streamlined Expedited Release ("Petition"), pursuant to Texas Water Code §13.2541 and 16 Tex. Admin. Code § 24.245(h), to be released from the water certificate of convenience and necessity ("CCN") area of Parker Water Supply Corporation, CCN No. 10911 ("Parker") in Johnson and Hill counties. The Petitioner shows as follows:

On January 26, 2022, the administrative law judge ("ALJ") filed Order No. 3 establishing a deadline of February 28, 2022, for the Staff ("Commission Staff") of the Public Utility Commission to file a recommendation on final disposition. On February 28, 2022, Commission Staff requested an extension of time and requested that Petitioner respond to the pleading filed by Parker Water Supply Corporation. Order No. 4 was issued in this case requiring Petitioner to provide a response by the fourth working day from issuance of the order.

PUC Rule § 22.4(b) allows for the extension of time for good cause. Petitioner is in active negotiation for sale of the property subject to the petition herein which, if effectuated, will result in Petitioner's withdrawal of the instant Petition. Petitioner believes that the sale will be completed within the next thirty days. As such, Petitioner requests an extension of the procedural schedule in this case by 30 days.

In the alternative, Petitioner requests that its March 7, 2022, deadline to respond to Parker WSC's argument be extended to April 7, 2022, in order to be allowed to fully respond.

The undersigned attempted to confer with Parker WSC and Commission Staff regarding this Request. Neither party responded.
