ORDER NO. 3 FINDING PETITION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE AND NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the administrative completeness of the October 20, 2021 petition of Troy Bradshaw to amend Parker Water Supply Corporation's certificate of convenience and necessity (CCN) in Johnson and Hill counties by streamlined expedited release. On November 22, 2021, Mr. Bradshaw filed a supplement to the petition.

I. Finding Petition, as Supplemented, Administratively Complete and Notice Sufficient

On January 20, 2022, Commission Staff filed recommendations regarding the administrative completeness of the petition, as supplemented, and sufficiency of notice. The administrative law judge finds the petition, as supplemented, administratively complete and notice sufficient.

II. Establishing Procedural Schedule

Under Texas Water Code § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
