

**MARILEE SPECIAL UTILITY DISTRICT’S RESPONSES TO

QUESTION NOS. STAFF 1-1 THROUGH STAFF 1-11**

COMES NOW, Marilee Special Utility District (the “District”) and files this, its Response to Commission Staff’s First Request for Information, which was filed on January 11, 2022. Due to a clerical error, the District did not receive the First Request for Information until February 24, 2022, at which time the District conferred with Commission Staff and Petitioner regarding an extension of time to file the District’s responses. Neither Commission Staff nor Petitioner opposed an extension until March 10, 2022. The Honorable Administrative Law Judge (“ALJ”) declined to rule on the District’s unopposed motion for an extension of time, as there is no right to discovery in streamlined expedited release cases, though the parties may participate in discovery. Accordingly, the District’s responses are filed within the period agreed to by the parties.



- Meter No. 1301 is located inside the western boundary of the Tract and is currently active;
- Meter No. 45 is located inside the southern boundary of the Tract and is currently active; and
- Meter No. 299 is located inside the southern boundary of the Tract and is currently active.

- A 6" waterline, inside the southern boundary of the Tract.

RESPONSE: In addition to the water lines within the Tract, the following, nonexhaustive list describes the location of active District water lines are in close proximity to the Tract:

- Approximately 800 feet of a 3” water line is within 100 feet of the northern boundary of the Tract;
- Approximately 600 feet of a 2” water line is within 100 feet of the northern boundary of the Tract;
- Approximately 1,000 feet of a 1 ½” water line is within 800 feet of the eastern boundary of the Tract;
- Approximately 900 feet of a 4” water line is within 800 feet of the eastern boundary of the Tract;
- Approximately 800 feet of an 8” water line runs from the southeast corner of the Tract to the east; and
- Approximately 600 feet of a 2” water line runs from the southeast corner of the Tract to the south.
