COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF THE PETITION AND REQUEST FOR REFERRAL

On October 27, 2021, the McAllen Public Utility (McAllen) filed a petition with the Public Utility Commission of Texas (Commission), under Texas Water Code (TWC) § 12.013, appealing the wholesale water rates charged by the Hidalgo County Water Improvement District No. 3 (Hidalgo). McAllen requests that the Commission (1) establish interim rates during the pendency of this proceeding; (2) issue an order compelling Hidalgo to continue providing water service to McAllen in accordance with the existing contract; (3) find the rates adversely affect the public interest; (4) establish a reasonable water rate; and (5) order Hidalgo to refund all payments in excess of the reasonable rate fixed by the Commission.

On October 28, 2021, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of November 29, 2021 for Commission Staff (Staff) to file a recommendation whether the appeal meets the requirements of 16 Texas Administrative Code (TAC) § 24.305. Therefore, this pleading is timely filed.

I. SUFFICIENCY OF THE PETITION

Staff has reviewed McAllen's petition and, as supported by the attached memorandum of Emily Sears, Rate Regulation Division, recommends that McAllen's appeal meets the requirements of 16 TAC § 24.305 and is sufficient for filing. This recommendation does not address the merits of the petition.

II. REQUEST FOR REFERRAL

In accordance with Staff's sufficiency recommendation and with 16 TAC § 24.307(a), Staff respectfully requests that the Commission refer the petition to the State Office of Administrative Hearings (SOAH) for an evidentiary hearing. In response to McAllen's request that interim rates be decided by the Commission in a preliminary order, Staff recommends that this issue be referred

to SOAH as well. Staff anticipates there will be questions of law and fact that may need to be developed to properly address McAllen's motion for interim rates.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests the entry of an order finding the appeal sufficient and referring the proceeding to SOAH.
