**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On October 28, 2021, Royal Valley Utilities, Inc. (Royal Valley) filed an application for approval of a proposed pass-through rate change related to North Fort Bend Water Authority's gallonage charge, effective January 1, 2022.

On October 29, 2021, the administrative law judge (ALJ) filed a Notice Setting Deadline for Commission Staff Recommendation on the Application and Notice, establishing a deadline of November 29, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file its recommendation. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On November 5, 2021, Royal Valley filed an additional pass-through increase request in this case. Staff requires more time to analyze the additional filing in this case. Accordingly, Staff respectfully requests an extension to December 10, 2021 for Staff to file a recommendation.

**II. CONCLUSION**

As detailed above, Staff respectfully requests the entry of an order extending the deadline for Staff to file a recommendation to December 10, 2021.
