The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: Margaritaville Lake Resort, Inverness at Del Lago.

The requested area is located approximately <u>2.7</u> miles <u>northeast</u> of downtown <u>Montgomery</u>, Texas, and is generally bounded on the north by <u>Walden Road</u>; on the east by <u>Fountainview Drive</u>; on the south by <u>Lake Conroe</u>; and on the west by <u>Walden Road</u> and <u>Lake Conroe</u>.

The requested area includes <u>294</u> water customer connections, <u>289</u> sewer customer connections, and includes approximately <u>282</u> acres of transferred area from Conroe Resort Utilities, LLC (CCN Nos. 11942 and 20638) to Undine Development, LLC (CCN Nos. 12407 and 20948).




If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
