**COMMISSION STAFF’S REQUEST FOR EXTENSION**

**I. INTRODUCTION**

On November 8, 2021, Conroe Resort Utilities, LLC (Conroe) and Undine Development, LLC (Undine) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Montgomery County. On August 25, 2022, the application was amended to replace Undine Development, LLC with Undine Texas, LLC (Undine Texas) and Undine Texas Environmental, LLC (Undine Texas Environmental) as the applicants.

On January 19, 2023, the administrative law judge (ALJ) filed Order No. 16 requiring parties to clarify two issues by February 3, 2023. On February 3, 2023, Undine filed for an extension after conferring with Commission Staff. Due to a miscommunication with Undine, Staff did not submit clarification on the two issues the ALJ had ordered parties to address by February 3, 2023.

**II. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Undine to address some of the issues the ALJ wanted clarified and needs additional time before submitting the required clarifications. Accordingly, Staff respectfully requests that the deadline for Staff to file clarifications be extended until February 21, 2023. Staff has conferred with counsel for Undine and is authorized to represent they support the proposed extension.

### III. CONCLUSION

For the reasons stated above, Staff respectfully requests that its deadline to file clarifications be extended until February 21, 2023.
