**APPLICANTS' RESPONSE TO ORDER NO. 17**


Undine Texas, LLC and Undine Texas Environmental, LLC (collectively, “Undine” or “Applicant”) hereby submit this response to Order No. 17. Order No. 17 directed Undine to issue revised notice by February 17, 2023 and file proof of the issuance of the revised notice on or before March 3, 2023.

**I. DISCUSSION**

On December 20, 2022, Undine filed its Notice of Intention to Conclude Transaction” (Docket Id. No. 52797-131). Undine thereby notified the Administrative Law Judge (“ALJ”) and the parties of its intention to conclude the transaction pursuant to Texas Water Code § 13.301 and Commission Rule 16 Tex. Admin. Code § 24.239 based on the conclusion of the 120-day notice period on December 15, 2022. Undine subsequently provided notice of the close of the transaction to the ALJ and the parties on February 1, 20223 (“Notice of Close of Transaction”; Docket Id. No. 52797-137).

Because Undine has completed the notice period and concluded the transaction, consistent with Texas Water Code § 13.301 and Commission Rule 16 Tex. Admin. Code § 24.239, it is Undine’s position that further notice, and therefore compliance with Order No.17, is unnecessary and in conflict with the applicable statutory and regulatory provisions and the procedural history of this matter, and that it would create confusion within the applicable customer base. Undine is prepared to present any briefing as the ALJ may request on this matter.
