Transfer of Water and Sewer Facilities from Conroe Resort Utilities LLC to Undine Texas LLC. 52997

I am submitting this letter to intervene in the subject transfer rate increases as noted in the attachment provided by Undine Texas LLC. There does not seem to be any logical justification why both the water and sewer rates should increase by such extreme percentages for the same service. Logic says that the approved rates for Conroe Resort Utilities LLC should be the same rates for that facility and not some approved rates for Undine's other facilities.

There has been no justification provided for the extreme increases. The facility and customer base is the same and Hay's utility is continuing to provide the billing and support services. I hope the Commission will review this transaction and come to the conclusion that the existing Undine LLC rate approval for their other activities should not be applied to the Conroe Resort Utility facility.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326. Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Heaving- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
