Dear Commissioners and Representative Metcalf

I wrote previously, of which a copy is attached. I re-express my concerns set out in that letter. I again oppose the proposed rates by Undine Texas LLC.

New and more specific information has come to my attention.

Undine's proposed rates are set out in the attached documents. As best as I can determine, the increased water rates increase at least 250% over the next three years. This has a significant and dramatic impact on my water bills, and on everyone who is affected. This proposed increase constitutes **gouging** in its ultimate form.

My water bills totaled \$2,054.98 for the past 12 months, or on average \$171.25 per month. Undine's proposed rate increases in year 3 would result in my water bills being approximately \$5,138/year or approximately \$428/month.

The affected residents are largely retired and on a fixed income, as am I. The approximately \$3,000 a year increase is extremely significant to the affected residents.

To demonstrate how ridiculous these are, by comparison my electric bills in the last 12 months totaled \$2,060.76, i.e., only \$5.76 more than my water bills. Therefore, my water bills under Undine's proposed rate increases will be more than my electricity bills. This is just not right.

I urge you all to reject Undine's proposed increases and deem them to be extreme, unjustified and gouging.

Re: Docket No. 52797

I am writing in opposition to the proposed sale of Conroe Resort Utilities to Undine Texas, LLC and Undine Texas Environmental, LLC (collectively Undine) and to the proposed increases in water rates by Undine.

I am a resident of Del Lago subdivision, retired, and on a fixed income.

My water bills for the months of May, June and July totaled \$815.71 (I don't have my September bill for August yet). And I was gone for 9 weeks in May-July; therefore, my bills would have been even higher if I had been here the entirety of those 3 months.

I understand that our current rates are:

Water: \$27.42 base rate; \$2.28 per 1,000 gallons Sewer: \$36.91 base rate; \$3.68 per 1,000 gallons

I also understand that the proposed new rates are:

Water: \$40 base rate; \$5 per 1,000 gallons Sewer: \$70 base rate; \$12 per 1,000 gallons,

In other words, the proposed rates are more than double the current rates. I also understand that these rates may be immediate or may be phased in over 3 years. Let's assume these rates are the ones for three (3) years from now. That means that my bills for May-July in year 3 will not be \$815.71, but will be more on the order of \$1,750, or on the order of \$600 per month and likely much more, since I was gone for 9 weeks during the May-July timeframe. The proposed rates would more than double my current water bill.

This is outrageous and gouging.

I therefore strongly oppose the proposed sale and rate increases.
