I'm writing this letter to become an intervenor and protest the proceedings filed by Conroe Resort Utilities and Undine Texas. I'm protesting the rate increases.

The water/sewer rate increase going from \$29.70 per month to \$81.22 per month for usage up to 2,000 gallons is astronomical. If you use 500 gallons or 10,000 per month you get billed more also. The sewer bill is going from \$44.27 per month up to \$110.00 per month. The total increase of \$117.00 per month!!!!

I was never notified in the summer of 2022 about a rate increase as Undine wrote in a letter that we were notified. There are 50 household cottages that were being sold at the time that didn't even have addresses. These were rental cottages that were owned by the Margaritaville resort and they never had individual addresses. They sold them off and it took months on end in 2022 to get addresses for these cottages and to get them filed with Montgomery County Appraisal District. If we were mailed a letter who knows where it went and I don't letters were even sent to the debacle with getting addresses with the post office and Montgomery County Appraisal District. None of my neighbors re call receiving a notice either.

You are also being unfair with billing around 296 homes with this high increase and Margaritaville Resort uses as much water/sewer as all the other 296 homes.

Margaritaville resort has 320 rooms, restaurants, bars, multiple swimming pools, 300 plus employees, golf course, etc. They are using more water than the other 296 households but the households are taking the brunt of the increase more.

Look at the rate breakdown Margaritaville is coming out on the sweet side of this deal! Plus it's easy for them just to say ok were going to raise the cost of every mixed drink and meal .25 cents to cover this water bill increase. Destination tourist resort what's another quarter to our guest!

This rate increase is proposed over a 3 year period. What's the rate after 3 years after these supposed improvements are done? Stay the same or go up or go down who knows! Will the improvements even get done? What if Undine flows in all

this extra money and decides not to do any repairs and then sells it off to another company?

I can't understand that we were sent notice of rate increase without it getting approved by the PUC. We were told to intervene which I am and others are too but in the meantime we are already getting the increased water/sewer bills. Why now why weren't we told we could intervene before the higher bills started coming in? I can't see in the public documents that this new rate was approved and where it happened.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
