Commissioners,

Please accept this letter as a formal protest against the astronomically high rate increases proposed by Undine Development LLC which represent, for a basis of 2000 gallons of water usage per month, a 270% increase in water rates (from \$29.70 to \$81.22) and a 2500/4 increase in sewer rates (from \$44.27 to \$110). These exorbitant rate increases reflect the greed and price gouging of private corporations which are steadily increasing their market share of water systems. These corporations are utilizing rate hikes to maximize profits (which by definition is their bottom line) and inflate executive salaries. But these rate hikes will put undue hardship on our community which consists mainly of retirees, many of whom are living on a fixed income. Because living without water is not an option, these residents will be forced to cut back on other essentials to pay for this service.

I urge the commission to intervene on the behalf of the affected residents to ensure that our community has access to affordable water. At a very minimum, I urge you to demand that Undine Development LLC be accountable and transparent and share with their customers the basis for this astronomical price increase.

Dear Rep. Metcalf,

The residents of the Del Lago subdivision of Montgomery are in shock about the new rates charged for water and sewer services. In February, many residents protested as documented by the PUC. (**Docket No 52797** - Undine Development LLC Service Conroe Resort Utilities)

Please accept this letter as a formal protest and expression of our significant discontent with the astronomically high rate increase as well as proposed 3 years continued increases by Undine Development LLC. This first-year increase hits hard and the future hikes will devastate this little community. This month, for a 2,000-gallon usage, the charges have doubled (\$31.98 to \$60.76) and the sewer a 59% increase (\$44.27 to new minimum \$75.00). The incremental 3-year rate for water will be a minimum of \$50.93 with zero gallons used plus as much as a base rate of \$254.65 plus \$8.18 per thousand gallons used. A monthly flat rate of \$110 for sewer regardless of water usage favors only the extremely high-volume users like local commercial properties.

These increases are ridiculous and represent profiteering at the expense of retirees and ordinary citizens. It will create significant hardships for all families impacted by such unjust increases. The water and sewer services **will not** change; just cost more to neighborhood families.

We implore you to protect us from this travesty. This monopoly should not be allowed to gouge customers who cannot buy water or sewer services elsewhere and we strongly plead with you to intervene on behalf of affected residents.

Attached you can see Undine's three-year increases in water and sewer services that we have to look forward to. Please, please prevent this from happening to us.
