REQUEST FOR HEARING**

The Office of Public Utility Counsel (“OPUC”) representing the interests of residential and small commercial consumers in Texas, respectfully submits its request for a hearing on the merits pursuant to Commission Order No. 24. OPUC filed a motion to intervene on April 4, 2022, and on April 13, 2022, Commission Order No. 7 granted OPUC’s intervention. OPUC and Staff previously requested a referral of this proceeding to the State Office of Administrative Hearings on hearing on April 14, 2022.<sup>1</sup> Commission Order No. 24 established a deadline for Staff to file a request for a hearing on the merits by May 12, 2023. Order No. 24 does not have a deadline for intervenors to request a hearing. OPUC therefore files this request on the same date that Order No. 24 establishes for Staff to file a request for a hearing. Therefore, pursuant to Commission Order No. 24, this request for a hearing is timely filed.


