COMMISSION STAFF’S REQUEST FOR EXTENSION

I. INTRODUCTION

On November 8, 2021, Conroe Resort Utilities, LLC (Conroe) and Undine Development, LLC (Undine) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Montgomery County. On August 25, 2022, the application was amended to replace Undine Development, LLC with Undine Texas, LLC (Undine Texas) and Undine Texas Environmental, LLC (Undine Texas Environmental) as the applicants.

On May 23, 2023, the administrative law judge filed Order No. 27, requiring Commission Staff to file recommendations on whether the Applicants’ capital improvement plans satisfy the requirements of the Commission, on the loan documentation or request for a good cause exception, and on the Applicants’ supplemental notice by June 23, 2023.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is still reviewing Undine’s supplemental information and needs more time to complete its review. Accordingly, Staff respectfully requests that the deadline for Staff to file its recommendations be extended to June 30, 2023. Staff attempted to confer with counsel for Undine but was unsuccessful.

III. CONCLUSION

For the reasons stated above, Staff respectfully requests that its deadline to file its recommendations be extended to June 30, 2023.
