

To Whom It May Concern:

I am writing to express concern regarding the intended purchase of our current water company by Undine Development, LLC.

We are residents of the Del Lago subdivision in Montgomery, Texas and we are currently served by Conroe Resort Utilities, LLC. Our current rate is \$27.42 base plus \$2.28 per 1,000 gallons for water. We pay \$36.91 base rate plus \$3.68 per 1,000 gallons for sewer. Undine Development, LLC would essentially double our current rate for both water and sewer. The rate listed on the website Undine referenced in their letter states that they would charge a minimum of \$40.00 plus \$5.00 per 1,000 gallons for water and a minimum of \$70.00 plus \$12.00 per 1,000 gallons for sewer. We find this price increase to be completely unreasonable.

We would like the Public Utilities Commission to investigate the intended purchase by Undine Development, LLC of Conroe Resort Utilities, LLC and intervene on behalf of the residents of Del Lago to ensure that rates we are charged for water and sewer do not increase so drastically.

has submitted an application with the Public Utility Commission of Texas (Commission) to purchase all of the water facilities and to transfer water certificated service area under CCN No. 11942 and all of the sewer facilities and to transfer sewer certificated service area under CCN No. 20638, in Montgomery County, TX from:

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision:

Margaritaville Lake Resort, Inverness at Del Lago.

The requested area is located approximately 2.7 miles <u>northeast</u> of downtown <u>Montgomery</u>, Texas, and is generally bounded on the north by <u>Walden Road</u>; on the east by <u>Fountainview Drive</u>; on the south by <u>Lake Conroe</u>; and on the west by <u>Walden Road</u> and <u>Lake Conroe</u>.

The requested area includes <u>294</u> water customer connections, <u>289</u> sewer customer connections, and includes approximately <u>282</u> acres of transferred area from Conroe Resort Utilities, LLC (CCN Nos. 11942 and 20638) to Undine Development, LLC (CCN Nos. 12407 and 20948).

See enclosed map showing the requested area.

This transaction will change a customer's rates and services to the current approved rates and services of Undine Development, LLC, which are higher than the current approved rate for Conroe Resort Utilities, LLC for a 5/8" meter. individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
