#### JOINT REQUEST FOR EXTENSION

On November 20, 2023, Conroe Resort and Undine, together with Staff of the Public Utility Commission; and the Office of Public Utility Counsel (collectively, the Parties), filed a Joint Motion for Remand (the Motion). On November 28, 2023, the Administrative Law Judge (ALJ) issued Order No. 4 denying the Motion and establishing a deadline of December 15, 2023 for the submittal of a settlement package.
