**JOINT REQUEST FOR EXTENSION**


On November 20, 2023, Conroe Resort and Undine, together with Staff of the Public Utility Commission; and the Office of Public Utility Counsel (collectively, the Parties), filed a Joint Motion for Remand (the Motion). On November 28, 2023, the Administrative Law Judge (ALJ) issued Order No. 4 denying the Motion and establishing a deadline of December 15, 2023 for the submittal of a settlement package. Pursuant to Order No. 5, the ALJ extended that deadline to January 5, 2023.

Commission Staff and Undine hereby request a further extension to the deadline to submit a settlement package, to January 22<sup>nd</sup>. While the Parties have been working diligently to address the issue, the holidays and other complications cause the Parties to need additional time to submit the requested information. Commission Staff and Undine represent they are not requesting this extension for purposes of delay. The undersigned contacted Staff of OPUC for their position on the motion and did not receive a response in advance of this filing.
