COME NOW Undine Texas, LLC, and Undine Texas Environmental, LLC (collectively, "Applicants") and Commission Staff (together, the "Parties") and file this Joint Statement of Clarification in response to Order No. 35, in which the Administrative Law Judge (ALJ) directed the Parties to "clarify the statement that the transaction has not administratively closed" by July 8, 2024. The Parties provide the following information in response to the Order:

The Parties state that the transaction "has not administratively closed" only because no order approving the sale to close has been issued by the Commission.
