**COMMISSION STAFF’S RECOMMENDATION ON SUFFICIENCY OF THE  
APPLICATION AND PROPOSED PROCEDURAL SCHEDULE**

On November 8, 2021, Texpo Power, LP (Texpo) filed an application to amend its retail electric provider (REP) certificate No. 10126 under PURA<sup>1</sup> § 39.352 and 16 Texas Administrative Code (TAC) § 25.107. Texpo seeks the amendment to reflect the addition of the assumed name Rio Power & Light.

On November 10, 2021, the administrative law judge filed Order No. 1, requiring the Staff of the Public Utility Commission of Texas (Staff) to file a recommendation on sufficiency of the application and propose a procedural schedule by November 29, 2021. Therefore, this pleading, is timely filed.

**I. SUFFICIENCY OF THE APPLICATION**

Staff has reviewed Texpo’s application to amend its REP certificate and recommends that it is sufficient for further review. This recommendation does not address the merits of the application.

**II. PROPOSED PROCEDURAL SCHEDULE**

In accordance with Staff’s sufficiency recommendation, Staff proposes the following procedural schedule:
