#### **UNOPPOSED MOTION TO ABATE**

COMES NOW CSWR-Texas Utility Operating Company, LLC ("CSWR-Texas") and files this Unopposed Motion to Abate. Staff of the Public Utility Commission of Texas ("Staff") is unopposed to this motion. In support, respectfully CSWR Texas shows the following:

#### I. BACKGROUND

On November 9, 2021, Copano Cove Water Company, Inc. and CSWR Texas (collectively, the "Applicants") filed an application with the Commission for approval of the sale, transfer, or merger of facilities and certificate rights in Aransas County. The requested transfer area includes approximately 1,267 acres and 713 water and connections. Public Notice was completed on December 20, 2021. Under 16 TAC § 24.239(i)(1) and Texas Water Code § 13.301(f)(1), the proposed transaction would be able to be closed 120 days after public notice on April 19, 2022 without Commission approval.

## II. MOTION TO ABATE

CSWR Texas has informed Staff that new information regarding the proposed transaction may need to be reflected in Staff's recommendation on the transaction. In order to give Staff time to review the new information, file a revised recommendation on the transaction, and for the parties to file a proposed order on the transaction, CSWR Texas respectfully requests an abatement of the case and agrees to a tolling of the 120-day review period. CSWR Texas and Commission Staff anticipate that the new information can be filed and reviewed promptly. If the abatement is granted, CSWR Texas requests that the case be unabated and a procedural schedule established after Commission Staff files its revised recommendation.

#### III. CONCLUSION

For these reasons discusses above, CSWR Texas respectfully requests that an order be issued abating this proceeding until Commission Staff files a revised recommendation on the transaction.
