Pursuant to Texas Water Code § 13.257(r) and (s), CSWR-Texas Utility Operating Company, LLC (CSWR Texas), holder of water Certificate of Convenience and Necessity (CCN) No. 13290, hereby files this Boundary Description for the CSWR Texas water system, which is located in Aransas County, Texas.

In accordance with the aforementioned statute, CSWR Texas affirmatively states that its water service area included in the aforementioned CCN is as follows:

The requested area is located approximately 3 miles northwest of downtown Rockport, Texas, and is generally bounded on the north by Copano Bay; on the east by Farm-to-Market 1781; on the south by Rattlesnake Point Road; and on the west by Copano Bay.

The requested area comprises approximately 1,267 acres and 713 water connections.

The service area is further depicted in the attached PUC certified map.

The Boundary Description is being filed on behalf of and at the request and instruction of CSWR Texas based upon information and belief. CSWR Texas specifically authorizes the filing of this Boundary Description to comply with Texas Water Code § 13.257(r) and (s) and its associated rules and regulations.




