#### **COMMISSION STAFF'S MOTION TO DISMISS**

On November 15, 2021, Conroe Resort Utilities, LLC (Conroe Resort) filed an application under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for approval of a pass-through rate change for an increase in the fees billed by the San Jacinto River Authority.

On March 15, 2022, the administrative law judge (ALJ) filed Order No. 4, establishing a deadline of April 15, 2022, for Conroe Resort to cure deficiencies set out by Staff in its recommendations filed on December 15, 2021 and January 28, 2022. Order No. 4 also set a deadline of April 29, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the true-up report, pass through rate change, and proposed notice or a motion to dismiss this proceeding. Therefore, this pleading is timely filed.

#### I. MOTION TO DISMISS

To date, Conroe Resorts has not filed a response to Staff's recommendations filed on December 15, 2021 and January 28, 2022. Therefore, Staff recommends that Conroe Resorts' application be dismissed without prejudice for failure to amend an application such that it is sufficient after repeated determination that the application is insufficient. <sup>1</sup>

## II. CONCLUSION

For the reasons detailed above, Staff respectfully requests that an order be issued dismissing the application without prejudice.
