JOINT PROPOSED PROCEDURAL SCHEDULE

I. INTRODUCTION

On November 16, 2021, Terra Southwest, Inc. (Terra) and Undine Development, LLC, filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Denton County. On August 26, 2022, the application was supplemented to replace Undine Development, LLC with Undine Texas, LLC (Undine).

On March 27, 2023, the administrative law judge filed Order No. 23, directing parties to file a proposed procedural schedule for continued processing of this application by March 31, 2023. Therefore, this pleading is timely filed.

II. PROPOSED PROCEDURAL SCHEDULE

Parties propose the following procedural schedule for further processing of the docket:

Event	Date
Notice complete	February 19, 2023
Deadline for intervention	March 21, 2023 ¹
Deadline for Staff to request a hearing or file a recommendation on the approval of the sale	April 20, 2023
Deadline for parties to file a response to Staff's recommendation on approval of sale	May 4, 2023

¹ Under 16 TAC § 24.239(b), the intervention period shall not be less than 30 days unless good cause is shown. Notice was mailed on February 9, 2023 and published on February 12 and 19, 2023. Therefore, 30 days after February 19, 2023 is March 21, 2023.

Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed	May 18, 2023
120 day deadline for the Commission to approve the sale or require a hearing	June 19, 2023 ²

III. CONCLUSION

For the reasons detailed above, parties respectfully recommend that the proposed procedural schedule be adopted.


