## CENTRAL STATES WATER RESOURCES, INC.'S DESIGNATION OF PROTECTED MATERIALS

Pursuant to the protective order entered in this proceeding,<sup>1</sup> Central States Water Resources Inc. ("Central States") is designating certain confidential material attached to its motion to intervene filed on November 23, 2021 as Highly Sensitive Protected Material. The undersigned counsel for Central States has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the Public Information Act and merits the Protected Materials designation.

Highly Sensitive Exhibit A contains the executed Purchase Agreement between Central States and Terra Southwest, Inc. The terms and pricing information of the Purchase Agreement are not publicly available, are commercially sensitive, and public disclosure of the information would cause substantial competitive harm to Central States and its affiliates and subsidiaries. Any other entity that seeks to acquire water utilities in Texas and elsewhere could use the information to its competitive advantage to the detriment of Central States. Accordingly, the information contained in Highly Sensitive Exhibit A is exempt from public disclosure under Tex. Gov't Code §§ 552.101, 552.104 and 552.110.
