JOINT MOTION TO ADMIT EVIDENCE

I. INTRODUCTION

On November 16, 2021, Terra Southwest, Inc. and Undine Development, LLC filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Denton County. On August 26, 2022, the application was supplemented to replace Undine Development, LLC with Undine Texas, LLC (Undine).

On June 21, 2023, the administrative law judge filed Order No. 27, requesting that parties file a joint motion to admit any additional relevant evidence that has not been previously sought for admission into the record by June 30, 2023. Therefore, this pleading is timely filed.

6. Commission Staff’s Comments on Supplemental Filings, including a confidential attachment, filed on June 30, 2023 (AIS Item Nos. 135 and 136).
