COMMISSION STAFF'S REQUEST FOR EXTENSION

On November 16, 2021, Terra Southwest, Inc. (Terra) and Undine Development, LLC (Undine), (collectively, Applicants), filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Denton County. Applicants filed supplemental information on November 17, December 13, 2021 and January 24 and April 29, 2022.

On May 12, 2022, the administrative law judge (ALJ) filed Order No. 8 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to request a hearing or file a final recommendation on approval of the sale and CCN amendment by June 13, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Given the novel nature of this application, Staff needs additional time to review the application and make a recommendation. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file request a hearing or file its final recommendation to June 27, 2022. I have conferred with counsel for Undine and am authorized to represent they are unopposed to the request.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to June 27, 2022, to request a hearing or file a final recommendation on approval of the sale and CCN amendment.
