# **COMMISSION STAFF'S REQUEST FOR EXTENSION**

## I. INTRODUCTION

On November 16, 2021, Terra Southwest, Inc. (Terra) and Undine Development, LLC (Undine Development), filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Denton County. On August 26, 2022, the application was supplemented to replace Undine Development with Undine Texas, LLC (Undine Texas).

On January 6, 2023, the administrative law judge (ALJ) filed Order No. 21, requiring parties to clarify a number of issues by January 18, 2023. Therefore, this pleading is timely filed.

## II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Undine to address some of the issues the ALJ wanted clarified and needs additional time before submitting the required clarifications. Accordingly, Staff respectfully requests that the deadline for Staff to file clarifications be extended until February 3, 2023. Staff has conferred with counsel for Undine and is authorized to represent they support the proposed extension. Staff also conferred with counsel for Terra and is authorized to represent they are unopposed to the proposed extension.

## III. CONCLUSION

For the reasons stated above, Staff respectfully requests that its deadline to file clarifications be extended until February 3, 2023.
