**COMMISSION STAFF’S RESPONSE TO ORDER NO. 6**

On November 29, 2021, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Walter J. Carroll Water Company, Inc. (Carroll Water) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Ellis County. Applicants seek approval to sell and transfer all of Carroll Water's water systems under CCN number 11543 to CSWR-Texas CCN No. 13290. The application reflects a requested area of 1,668 acres and 584 customers. Applicants filed supplemental information on November 23, 2021 and December 7, 2021.

On April 19, 2022, the administrative law judge filed Order No. 6, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to clarify the correct name for the applicant and recommend if this docket should be restyled by April 29, 2022. Therefore, this pleading is timely filed.

**I. REQUEST TO RESTYLE DOCKET**

Staff agrees that the correct name of Carroll Water is Walter J. Carroll Water Company, Inc. Therefore, Staff respectfully requests that the docket be restyled to “Application of Walter J. Carroll Water Company, Inc. and CSWR-Texas Utility Operating Company, LLC for Sale, Transfer, or Merger of Facilities and Certificate Rights in Ellis County”.

**II. CONCLUSION**

Staff respectfully requests the entry of an order restyling the docket.
