## REQUEST FOR EXTENSION

On November 23, 2021, Richard T. Lee (Mr. Lee) filed an appeal of the cost of obtaining service from Aqua Water Supply Corporation (Aqua WSC) under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On December 29, 2021, the administrative law judge filed Order No. 2, directing Commission Staff (Staff) to file a file a recommendation on the sufficiency of the notice and a recommendation on how to proceed with this petition and propose a procedural schedule by January 14, 2022. Therefore, this pleading is timely filed.

# I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Mr. Lee has not provided proof of his appeal being sent to Aqua WSC. Staff is unable to comment on the sufficiency of the notice without this filing. Staff requests Mr. Lee be ordered to file his notice of appeal by January 26, 2022. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff file a recommendation on the sufficiency of the notice and a recommendation on how to proceed with this petition and propose a procedural schedule to February 4, 2022.

Staff respectfully requests the entry of an order extending Staff's deadline to file a recommendation on the sufficiency of the notice and a recommendation on how to proceed with this petition and propose a procedural schedule to February 4, 2022.
