COMMISSION STAFF'S REQUEST FOR EXTENSION

On November 29, 2021, Flat Fork Water Supply Corporation (Flat Fork WSC) and the City of Center (the City) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Shelby County. Applicants seek approval to sell and transfer a portion of Flat Fork WSC's water system to the City's CCN No. 10397. The application reflects a requested area of 500 acres and 39 customers.

On July 26, 2022, the administrative law judge (ALJ) filed Order No. 10 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Applicants (jointly, Parties) to file a joint motion to admit evidence and proposed order approving sale and allowing the transaction to proceed by September 16, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR AN EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to draft and circulate a joint proposed order. Accordingly, Staff respectfully requests that the deadline for Parties to file a joint motion to admit evidence and proposed order approving sale and allowing the transaction to proceed be moved to September 23, 2022.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Parties' deadline to file a joint motion to admit evidence and proposed order approving sale and allowing the transaction to proceed be extended to September 23, 2022.
