**COMMISSION STAFF'S CORRECTION TO THE PROPOSED ORDER**

On November 29, 2021, Flat Fork Water Supply Corporation (Flat Fork WSC) and the City of Center (the City) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Shelby County. Applicants seek approval to sell and transfer a portion of Flat Fork WSC's water system to the City's CCN No. 10397. The application reflects a requested area of 500 acres and 39 customers.

On October 4, 2022, the administrative law judge (ALJ) filed Order No. 12 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Applicants (jointly, Parties) to jointly address a discrepancy discovered by the ALJ by October 14, 2022. Therefore, this pleading is timely filed.

**I. CORRECTION**

In response to the ALJ's Order No. 12, Staff has reviewed the Proposed Order and respectfully proposes the following correction to the Proposed Order:

Revise Finding of Fact 18 as follows:

18. Center has ~~no~~ violations listed in the TCEQ database.

Staff respectfully recommends that the Proposed Order be revised in accordance with the correction proposed above.
