## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

#### I. INTRODUCTION

On November 29, 2021, Flat Fork Water Supply Corporation (Flat Fork WSC) and the City of Center (the City) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Shelby County.

On February 13, 2023, the administrative law judge filed Order No. 16, directing parties to jointly file proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs by March 15, 2022.

# II. REQUEST FOR AN EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs more time to receive approval from Applicants to jointly file proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs. Accordingly, Staff respectfully requests an extension until March 22, 2023, to jointly file the proposed notice of approval.

#### III. CONCLUSION

Staff respectfully requests the entry of an order extending parties' deadline to March 22, 2023, to jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs.
