**AGREEMENT CONCERNING COMMISSION STAFF’S RECOMMENDATION OF
ADMINISTRATIVE COMPLETENESS OF THE APPLICATION**

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, Creedmoor-Maha Water Supply Corporation, and the City of Austin (collectively, “the Petitioner”) and files this Agreement Concerning Commission Staff’s Recommendation on Administrative Completeness of the Application.

On November 30, 2021, Creedmoor-Maha Water Supply Corporation and the City of Austin (collectively, Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) §13.248, and to amend Creedmoor-Maha’s water certificate of convenience and necessity (CCN) number 11029 and Austin’s water CCN number 11322 in Travis County, Texas.

On December 29, 2021, PUC Staff reviewed Petitioner’s application and found the application administratively incomplete and not accepted for filing at this time. The Staff further recommended that Petitioners be ordered to cure the deficiencies by January 28, 2022.

Petitioner does not disagree with Staff’s recommendation regarding the deficiencies in the Petition and agrees to work to cure the deficiencies as recommended by Staff by the deadline given of January 28, 2022.
