**COMPLAINT OF LILI AND THOMAS § PUBLIC UTILITY COMMISSION**  
**MCDEVITT AGAINST LEVI WATER §**  
**SUPPLY CORPORATION § OF TEXAS**

**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On December 2, 2021, Lili and Thomas McDevitt (Complainants) filed a complaint against Levi Water Supply Corporation (Levi WSC) regarding denial of water service.<sup>1</sup> The Complainants filed the formal complaint pursuant to 16 Texas Administrative Code (TAC) § 22.242.

On January 27, 2022, the administrative law judge (ALJ) filed Order No. 3, requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental statement of position regarding the complaint by March 7, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR AN EXTENSION**

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On February 25, 2022, Staff filed its first request for information to Levi WSC. 16 (TAC) § 22.144, provides a deadline for responses to be within 20 days of filing of a request for information. Twenty days from filing of Staff's request for information is March 17, 2022. Staff will require additional time to review the responses from Levi WSC and draft an appropriate supplemental statement of position. Accordingly, Staff requests that the deadline for Staff's supplemental statement of position be extended to March 31, 2022.

**II. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
